#### The Quattro Firm Believes In Female Empowerment

According to the National Women's Business Council, as of 2012 there were 9,932,424 womenowned businesses in the United States, however when it comes to women run law firms the numbers were few and far between. In fact, in 2013 the American Bar Association reported that women make up only 34% of the legal profession, and of those women only 20.2% were partners in the firms. As of April 2015, only 12 of the largest 100 U.S. run law firms have a woman in their highest leadership position. The Quattro Firm strives to make a change in these numbers.

Being an all female firm gives the Quattro Firm a unique advantage when it comes to handling cases and clients. In addition, being an all female firm fills us with a sense of pride and empowerment. We love to support female run businesses and each month we will recognize one female run company in the area.

As we continue our monthly celebration of female empowerment, the Quattro Firm had the distinct pleasure of taking a lunch with ballerina extraordinaire Lisa Lee of Lisa's Dance and Exercise. Lisa shared her story of her love of dance, which led to creating a part-time business in order to be able to spend time being a mother, and how her eclectic careers choices have shaped her business.



In 2013, Lisa decided that she'd like to start up a part-time business so that she could spend time with her young son and still have a profession. She had dance experience and had substituted for a

friend's ballet and tap dancing classes. After being a substitute, Lisa decided that she loved dancing with the young children and began offering classes in the clubhouse of her community. She began with two different classes: ballet and tap for girls ages 3-7 years and a creative movement class for children 18 months to 3 years old which was originally designed for boys as she was a mother to a little boy. Now this class is co-ed, but mostly a class for young girls.



Eventually, Lisa's business grew and grew. She began teaching classes at Cool Beans in Palm Beach Gardens and has had several different studio locations throughout Lake Worth. Her new studio, which opened in 2015 offers more than five styles of dance, as well as competitive dance teams, acting, music and art classes.

Lisa feels that her studio is different from the competitors because it offers more classes to younger children. She gears the classes in such a way as to engage the children on their level through the use of fun and child-appropriate props like ribbon wands, My Little Ponies, and reindeer antlers. Lisa additionally uses Disney music and themes like Frozen and Sofia the First. She believes in keeping the children innocent by not requiring make up, keeping the costumes modest and age appropriate as well as keeping the music G-Rated.

While being a woman ballet teacher is more socially acceptable, she has still faced some adversity in her field. Lisa told us that she's often not taken seriously, especially given her sunny and sweet demeanor. Since she's a people pleaser, vendors

have tried to take advantage of her by not paying for classes or with studio locations attempting to over-charge her for rent.



However, Lisa calls herself a big success. She attributes her success to the power of prayer and her eclectic background. After college, she had several different careers including the service industry, a legal secretary, as well as counseling and social work. She believes that her work in the service industry taught

her how to deal with people and this helps her to handle her teachers, vendors, service providers and parents of her students. Working as a legal secretary has given her some ability to understand the contracts and waivers, which are required for running a dance studio. Through counseling, she is able to work well with children and problem-solve.

As far as Lisa's favorite part of being a female dance teacher, it's the tutus. She gets to wear comfy clothes and be very girly, which is particularly fun since she's outnumbered by the boys in her household. Lisa is a proud mother of two little boys.

Lisa also loves the kids that she teaches. They are her favorite part of her classes. She gets to do something that she loves, while being silly and getting tons of hugs from little girls. Lisa also regaled us with humorous stories of the beauty of the honesty of children. While some women may be upset at being told by a 4 year old that her outfit didn't look good, Lisa laughs at it and appreciates the honest feedback.

As far as her favorite dances to choreograph, she enjoys the princess themed dances the most because she's really a kid at heart. She finds inspiration everywhere. For instance, in the current choreography for this session, she's been adding some jazz movements.

In three years, Lisa has choreographed all sorts of dances for classes and recitals. We were curious to know what her favorites were. She told us that she is really excited about "Friend Like Me" from Aladdin which is being performed by the 3 year old class for the current recital which will be in June at Boynton Beach high school. Lisa also really enjoyed the choreography during the Frozen themed session where the girls performed "snowflake" arabesques to "Let It Go."

Lisa advises other entrepreneurial women to be willing to commit a lot of time to their profession and to make sure that they have done all of the jobs personally at the outset in order to understand the employee perspective as the business grows. Additionally, a woman wanting to start her own business should be willing to learn; much of the outset of a business is learning all the aspects that go into it. She further advises that marketing is the first priority. Lisa spends half of her time marketing.

It was wonderful getting to hear how Lisa turned her love of dance and desire for a part-time career at her community clubhouse into a successful business. It is further encouraging to those of us who believe that a woman can do it all (be a successful mother and a successful business woman) to see how a woman with enough drive can reach all of her goals.
