Not only is Dr. Carolyn Agresti an award wining surgeon and doctor who is one of the most sought after doctors in South Florida, she's a role model and inspiration to women everywhere that it is possible to have it all.

I had the privilege of meeting Dr. Carolyn when she and her husband moved next door to my parents. As a teenage girl, I marveled at the idea that Dr. Carolyn had managed to have it all: a fulfilling and successful career (complete with advanced degrees), and a husband and family. At the time, I remember looking around at friends who were very concerned with boyfriends and settling down with a husband before a certain age and how frustrated I was by this process. It was then that I spoke to Dr. Carolyn and she said to me, "don't worry about marriage and a family; that will come on it's own. Go for your career because you really only get one shot." I credit the very talented Dr.



Agresti for my decision to go right through from college to law school and for the career woman that I am today.

As the health care climate began to change in 2014, Dr. Agresti thought that it might be best to take the plunge and start her own medical practice. She sought the advice of business and accounting professionals. With a lot of courage, intense organization, financial investment and the support of her husband, she opened her own practice.

Dr. Carolyn is an incredibly humble person. Despite the fact that I have sat in her waiting room with people who have driven from all over the state to see her, when I asked what she believes makes her one of the most sought after Ear, Nose and Throat specialists in the country, Dr. Carolyn humbly replied that it was a very kind statement and that she feels that she simply extends professional courtesy and expertise to any and all patients. She does admit that she listens carefully to her patients and exercises a lot of patience, which is of course crucial in the medical profession.

Dr. Carolyn credits her success as a woman in business to her dedicated leadership with her small practice where she leads her team of clinical and administrative staff members. She credits her team with her

success and states that she could not provide the level of care provided and sought after by her patients without the secretaries, medical assistants, the biller and the Chief Operations Officer behind her to ensure that she complies with the immense present healthcare regulations. As a woman in business, Dr. Carolyn works hard to stay current on the budgetary considerations and to keep reviewing her data to make necessary financial adjustments.

For Dr. Carolyn, when we asked about her favorite part of being a woman in the medical field, she discussed the unfortunate lack of women in the surgical specialties. When times get particularly tough, Dr. Carolyn says that they often joke that she should've become a dermatologist. Dr. Carolyn thinks this is because of the demanding hours and the need to be on call for emergencies. As a female surgeon, Dr. Carolyn loves that she can offer patients the option to choose to have a woman doctor/surgeon, if that is their preference.

As far as adversity, Dr. Carolyn is no stranger. She felt that as a woman who aspired to be a surgeon, she had to postpone her ideals of marriage and family until she had achieved her career goals. In this field, there did not seem to be any other supportive path. Additionally, Dr. Carolyn told us about a time when she had finished all of her training, signed a contract with Cornell as an assistant professor of Otolaryngology with more than adequate salary guarantees and she was denied a \$5,000 loan. Her brother, who is also a doctor and was in the same situation was not denied such a loan.

However, there are advantages to being a female physician/surgeon. Dr. Carolyn feels that sometimes female physicians are sought after for their compassionate bedside manner. Dr. Carolyn personally feels that women doctors are thought to be more approachable than their male counterparts. For Dr. Carolyn's patients, this is certainly their opinion as you can tell from her glowing reviews.

We asked if Dr. Carolyn had a favorite type of patient and why she preferred a select group but Dr. Carolyn laughs that she enjoys seeing all ages from "neonates to nineties." This often means that she cares for the entire family and she really enjoys being connected to her community in that way.

Dr. Carolyn told us about her best memory of having helped a patient was where a gentleman reported having two brief episodes of coughing up blood. His throat exam seemed normal, but Dr. Carolyn thought it best to call the gentleman's internist and express some concern. He was then immediately admitted to the hospital and diagnosed and treated for a pulmonary embolism. This call saved the man's life.

The best part of owning her own practice for Dr. Carolyn is the ability to make day-to-day practice decisions without having to get a group of doctors to agree. Doctors, much like lawyers, can often differ in opinions and argue both sides. Having the ability to make decisions without enduring a group decision can be a freeing experience.

We loved getting to know more about the medical profession and how female surgeons are both in demand and facing adversity. We'd like to thank Dr. Carolyn Agresti for her time and sharing her experiences. As someone who was a treating physician and surgeon to Jacqueline Kennedy Onassis, it's understandable why Dr. Carolyn is in such high demand.
